## **ABSOLUTE EARTH MOVEMENT EXCLUSION**

This endorsement modifies insurance provided under the following:

COMMERCIAL GENERAL LIABILITY COVERAGE PART  
COMMERCIAL LIABILITY UMBRELLA COVERAGE PART

This insurance does not apply to damages because of "bodily injury", "property damage", "personal injury", or "advertising injury" arising out of, caused by, resulting from, contributed to, aggravated by, or related to earth movement of any kind whatsoever, whether combined with water, including but not limited to earthquake, landslide, subsidence, mud flow, sink hole, erosion, or the sinking, rising, shifting, expanding, shrinking, contracting, consolidations, settling, slipping, falling away, collapse, caving in, eroding, rising, flowing, tilting, or any other movement of land, soil, earth or mud.

This exclusion applies regardless of the cause or causes of the earth movement, whether said cause or causes would otherwise form a basis for coverage of any other cause or causes of the "bodily injury", "property damage" or "personal injury"; or whether any other cause or causes acted jointly, concurrently or in any sequence with the earth movement.
