CONTRACTORS EXCLUSION

This endorsement modifies insurance provided under the following:

COMMERCIAL GENERAL LIABILITY COVERAGE PART
COMMERCIAL LIABILITY UMBRELLA COVERAGE PART

The following paragraphs are deleted from COVERAGE A – BODILY INJURY AND PROPERTY DAMAGE (Section I – Coverage): Paragraphs 1b.(3), c., d.

The following is added to paragraph 2., Exclusion of COVERAGE A – BODILY INJURY AND PROPERTY DAMAGE (Section I – Coverage) and paragraph 2., Exclusions of COVERAGE B – PERSONAL AND ADVERTISING INJURY LIABILITY (Section I – Coverages):

This policy does not apply to:

1. PENDING LITIGATION EXCLUSION

“Bodily injury”, “property damage”, or “personal and advertising injury” which is the subject of litigation against you or any additional insured, or any contractual party, or any officer, owner, partner, member, insurance manager and/or risk manager prior to the inception date of the policy, regardless of whether such “bodily injury”, “property damage”, or “personal and advertising injury” continues to occur or becomes progressively worse during the policy period.

2. CONTINUOUS AND PROGRESSIVE DAMAGE EXCLUSION

“Bodily injury”, “property damage” or “personal and advertising injury” which first occurs before the inception date of this policy, regardless of whether such “bodily injury”, “property damage”, or “personal and advertising injury” continues or becomes progressively worse during the policy period.

3. KNOWN DAMAGE EXCLUSION

“Bodily injury”, “property damage”, or “personal and advertising injury” which is known to you or any additional insured, or any contractual party, or any officer, owner, partner, member, insurance manager and/or risk manager prior to the inception date of this policy, regardless of whether such “bodily injury”, “property damage”, or “personal and advertising injury” continues or becomes progressively worse during the policy period.
